OFFICE ORDER

Sh. Chandan Kumar (DOB: 05.09.1973) was appointed as Asstt. Information Officer against Post Code 0034 through DSSSB against advertisement No. 02/2003 and consequently he joined in this Directorate on 02.12.2004.

In pursuance of O.M. No. 57/05/2021-P&PW(B) dated 03.03.2023 issued by the Department of Pension and Pensioner's Welfare, Government of India endorsed by the Finance Department, Government of NCT of Delhi vide F.No.20/07/2022/Finance(Policy)/951-959 dated 12.04.2023 and consequent upon Sh. Chandan Kumar (DOB: 05.09.1973), the then Asstt. Information Officer (presently Information Officer) has submitted his option vide letter dated 17.07.2023 to switch over from National Pension Scheme (NPS) to CCS (Pension) Rules 1972 (now 2021).

On the basis of relevant documents submitted by him and as per available record, it has been observed that Sh. Chandan Kumar (DOB: 05.09.1973), the then Asstt. Information Officer (Now Information Officer) was recruited against the posts/vacancies advertised/notified for recruitment, on or before 22.12.2003 and therefore, fulfills the condition as per para 04 of O.M. No. 57/05/2021-P&PW(B) dated 03.03.2023 issued by the Department of Pension and Pensioner's Welfare, Government of India therefore he is eligible for coverage under CCS (Pension) Rules, 1972 (now 2021).

Therefore, the Competent Authority has considered the request of Sh. Chandan Kumar (DOB: 05.09.1973), the then Asstt. Information Officer (Now Information Officer) and accorded approval for conversion under CCS (Pension) Rules, 1972 (now 2021) in place of National Pension System from date of joining in Govt. service i.e. 02.12.2004.

This matter has been examined in consultation with the accounts functionary of this Directorate. In case any discrepancy found at later stage, the same will be rectified in respect of the concerned officer/official without any prior intimation as per relevant prevailing rules / OMs.

This issues with the prior approval of the worthy Chief Secretary of Delhi.
