Sir,

Please refer to this Directorate letter No. F. (7)/2021/DIP/Pub/(DM)/1387-89 dated 2.3.2022 and subsequent letter No. (7)/2021/DIP/Pub/(DM)/2994-97 dated 25.04.2022 regarding printing of 1000 (one thousand) copies of each magazine (Hindi and Punjabi) at quoted rates.

The Directorate (I&P) vide Tender ID No. 2022_DIP_214285_1 had invited online bids from reputed firms and publication houses for printing of two monthly magazines (Hindi and Punjabi) upto five thousand (5000) each. The validity of the tender was two years (24 months).

After evaluating the Financial Bids your firms was selected as L-1 firm. Consequently, vide letter No. F. (7)/2021/DIP/Pub/(DM)/1387-89 dated 2.3.2022 you were requested to collect the material from Directorate (I&P) and start process for printing of one thousand copies of each magazine at quoted rates.

Vide letter Ref. No. JOP/DIP/2021-22/MARCH/21 dated 03/03/2022 you denied to carry out the directions of Directorate (I&P) for printing of one thousand copies of each magazine at your quoted rates.

Vide letter No. (7)/2021/DIP/Pub/(DM)/2994-97 dated 25.04.2022 you were once again requested to print 1000 copies of each magazine at your quoted rate. But this time too, you denied to print 1000 copies of each book/magazine at quoted rates and submitted to print 2000-2500 copies of each magazine at quoted rates.

Frequent denial from printing of 1000 copies of each magazine (Hindi and Punjabi) at quoted rate presents your adamant attitude that clearly violates the Terms and Conditions of the Tender.

These magazines are published for spreading of Government message far and wide. Magazines provide exhaustive and interpretative information about the policies and achievement of Government of NCT of Delhi. But due to your adamant and irresponsible attitude magazines could not be published on time.

Keeping in view of above, you are being debarred from applying in this Directorate (I&P) for any printing work up to 31st March of 2024.
