Minutes of the review meeting held under the Chairmanship of Hon'ble Minister (PWD) Sh. Satyendra Jain on 13.01.2016 at 11: 00 am with respect to prohibition of burning of any kind of garbage, leaves, waste, plastic, rubber etc and dust control at construction sites in compliance of NGT order in O.A. 21 of 2014 titled "Vardhman Kaushik Vs. UOI"

Special Secretary (Environment) briefed about the decisions taken in the last meeting held on 28.12.2015 and asked the officers of various departments present in the meeting to give details of the action taken in the last week.

Hon'ble Minister (PWD) made an observation that North Delhi Municipal Corporations have to make more efforts for controlling the dust from construction sites and burning of any kind of garbage, leaves, waste, plastic, rubber etc.

No Action Taken Report was provided by the officers from DDA. They informed that no case of burning of garbage, leaves, waste, plastic, rubber etc has been observed in 'O' zone area. They have also issued compliance of directions of the Hon'ble NGT dated 04.DDA representative informed that VC, DDA has issued directions to all concerned officers on 11.01.2016.

Hon'ble Minister, PWD took serious note of the inappropriate Action Taken Report being provided by the Officers of DDA despite observations of regular incidences of burning of garbage, leaves, waste, plastic, rubber etc in 'O' zone area. Considering no appropriate reply / action taken report from DDA

After detailed deliberations, following directions were given:-

3. For dust control at construction sites:

- Initially inspections were carried out at all districts of Delhi with 12 teams.

(Action by: DPCC)

- The matter requesting NGT to define the slabs of compensation amount with respect to dust control violations as per size of the plots is being put for necessary approval.

(Action by: Department of Environment/DPCC)

- No Officers from PWD attended the meeting. Action Taken Report regarding Inspection for dust control on its main roads stretching upto 1260 km and visit to all batch mixing plants operating in Delhi to be submitted positively in next meeting.

(Action by: Public Works Department)

- The officers from DMRC informed that review meeting has been taken up at Managing Director level. Strict instructions have been given to the contractors providing services to DMRC.

- (Action by: DMRC, DPCC)

- The municipal corporations / land owing agencies to submit action taken report regarding installation of display boards containing information on steps to be taken for dust control during construction activity at the construction sites. Municipal bodies to write to persons / agencies for taking up construction activities to take dust

control measures. Action Taken Report to be submitted positively in the next meeting alongwith details of plans of building / projects sanctioned in past 2 years.

(Action by: Concerned Municipal Corporation)

- Officers from Special traffic of Police said that the non- compoundable challans are send to court for collection of amount. Traffic police to submit details of challans for the last 2 months spacefically of vehicles/ trucks found violating dust control norms while carrying construction materials.

(Action by: Traffic Police, Concerned Municipal Corporation)

4. Prohibition on burning of leaves, garbage, etc.

- With regards to Solid Waste burning, DPCC Officials to conduct surprise visits in 'O' zone and parks under DDA. The concerned Officers of DPCC to be present in the next meeting with Action taken Report. Notices / challans to be issued for the Section Officer (Horticulture)/ Sanitary Inspector of Municipal Corporations and DDA. Municipal Corporations and DDA to submit Action Taken Report regarding prohibition of burning of any kind of garbage, leaves, waste, plastic, rubber etc.

(Action by: DPCC, Concerned Municipal Corporation & DDA)

All the departments were requested to submit weekly Action Taken Report positively. The officials from DDA present in the meeting should ensure submission of Action Taken Report of burning activities observed in 'O' zone of river Yamuna and dust control measures at construction sites under the jurisdiction of DDA, positively in the next meeting.

Next meeting will be convened on 27.1.2016 at 11.00 am at Conference Hall no.3, Delhi Secretariat.

Meeting ended with vote of thanks to the Chair.
